## Transferring Funds

## For Citi International Personal Bank clients who hold an Account with Citibank UK Limited.

You can send money from your Citi International Personal Bank account using a service called SWIFT. The SWIFT method of sending and receiving money can be used in all of the currencies listed below. SWIFT payments can be made via your Relationship Manager.

CHAPS is a service which enables you to send money on the same day to bank accounts in the UK, Channel Islands, Isle of Man and Gibraltar. Sending money through CHAPS is fee-free and can be made through your Relationship Manager.

## How to send money from your account

When you want to send money from your account you will need to give us certain details about the beneficiary and the beneficiary's account (including the beneficiary's bank). The details we need will depend on the type of service you decide to use. Further details are set out in the table below.
